The International Centre for Reproductive Health of Ghent University and the European Network **EN-HERA!** wishes to invite you to the **European Seminar for the Promotion of Sexual and Reproductive Health and Rights of Refugees and Asylum Seekers in Europe and Beyond**. This seminar will take place on **Friday, 21st November 2008** at Monastery Poortackere at the Oude Houtlei 56 in Ghent.

The overall aim of this seminar is twofold. First we will officially launch the **European Network** for the Promotion of Sexual and Reproductive Health of Refugees and Asylum Seekers in Europe and Beyond (EN-HERA!). Second, we will agree upon a standardized Good Practice Identification **Framework** in policy development, service delivery and participatory approach.

The preliminary program of the one day seminar is as follows:

After a welcome speech, the main issues in sexual and reproductive health & rights of refugees and asylum seekers in Europe will be introduced by keynote speakers reflecting the EN-HERA! cross-sectoral and multi-disciplinary approach. We foresee six keynote presentations of 12 to 15 minutes each. Subsequently, the project and research results will be presented as well as the draft Framework.

In the afternoon we will refine the framework working in parallel sessions. The conclusions of these workshops will be further discussed at a plenary session in order to agree upon a final framework. Eventually EN-HERA! will be officially launched.

Throughout the seminar, there will be multiple possibilities to network with different stakeholders. You will have the opportunity to visit the **Café Contact** by the EN-HERA members, where good practices can be shared and tools will be disseminated.
